Basic charge may include face painting and/or glitter tattoos. There is an additional \$25 fee for premium services of airbrush tattoos or henna art (see chart). FairyDust Faces artists can face paint or apply glitter tattoos in unlimited colors to approx. 12-15 children per hour.

Third party service charges (i.e., gig masters fees) are to be considered separate unless otherwise noted and not included in this quote. Verbal booking dates will be held for three (3) business days. Retainers are required immediately upon execution of the contract. The 50% retainer is non refundable should the client decide to cancel the event. In the case of postponement, FairyDust Faces will work with you to accommodate an alternate date one time. However, if a mutually agreeable date is not determined the retainer is retained by FairyDust Faces.

Limitations on Artwork: Artist(s) will not paint any part of body that is illegal to expose, or any place they do not feel comfortable painting. Artist(s) will not paint any design or wording that is obscene, offensive, or defies good taste. For sanitary reasons, artist(s) will not paint anyone who appears to be sick or suffering from cold sores, conjunctivitis, any infectious skin condition, open wounds or rashes.

Artist(s) agree(s) to provide services of general face painting using only Professional Theatrical Cosmetic grade FDA approved products on said dates with acceptance of 50% retainer. For any reason, should FairyDust Faces be unable to accommodate your paid booking, a full refund of your retainer will be returned to you or you may receive your next event for the equal amount of time with no further payment required.

Client agrees to pay the full amount of booked time upon artists arrival at event. To provide sheltered area in case of rain or extreme heat. This is non-negotiable with the airbrush service and any precipitation will cause service to be suspended. Any service time lost to rain is forfeited. Airbrush service also requires location within 50 feet of an electrical outlet and adequate lighting if a nighttime event. The client will be responsible for any fees or expenses, including attorney's fees, incurred in connection with collecting delinquent amounts owed to FairyDust Faces under this Agreement.
